I am the parent or legal guardian of the above-named student. I have been informed that the Manhattan Beach Unified School District's Choir Program and the Mira Costa Choir Boosters ("Choir Program") intends to take photographs and capture video during the 2022-23 school year to use in various capacities including live-streaming concerts, as part of slide shows, printed concert programs, and on our school/district websites and on social media. Concert videos will also be posted and available for public viewing on YouTube. The Choir Program may be making, or may hire a third party to make, virtual choir videos or recordings, "promo reels" and other edited videos to be distributed to the public as part of our recruitment efforts in the community and in area elementary schools, to promote the Choir Program, and to inform the community of the Choir Program's events. Student image and performances may be included in that footage, archived on certain social media sites, or otherwise used by the Choir Program as part of these efforts.

I grant permission for the Choir Program, and the third party they may hire for this purpose, to photograph, video tape, audio tape, and live broadcast my child in connection with Choir Program concerts and events as described above.

I hereby assign the Choir Program, and all of their current, former, and future agents, principals, representatives, and assigns, all rights, title and interest in, and to the use of the above-named student's image, likeness, voice, performance, work, and art through video, photographs, and any other media created by the Choir Program in connection with the concerts and events described above.

I also authorize the Choir Program, and their respective agents, to use the Media for educational, organizational, and program or series publicity purposes. I further consent to any reproduction, copyright, exhibition, broadcast, and/or distribution of the Media in whole or in part, without limitation or compensation.

I understand that my student's participation in the Choir Program concerts and events confers upon my and my student no rights to use, own, or copyright, in whole or in part, any of the materials created as part of the process of those concerts and events.

I release the Choir Program, and their employees, agents, and assigns, from all liability that may arise from any and all claims by me or my assigns, in connection with my student's participation in the concerts and events described above. I understand that neither me, nor my student and/or family will be compensated for any use of the Media. I waive any right that I may have to inspect or approve the Media, or the editorial, advertising, or printed copy or soundtrack that may be used in connection therewith, and any right that I may have to control the use to which said Media product(s) may be applied.

I hereby release and hold harmless the Choir Program from and against any claims that may arise regarding the use of my or my student's likeness, including but not limited to, any claims of defamation, invasion of privacy, infringement of moral rights, or rights of publicity or copyright. I agree to hold the Choir Program, its contractors, agents, and employees harmless against any liability, loss or damage

(including reasonable attorney's fees) caused by or arising from the exhibition or telecast of my student's appearance in the concerts and events described above, or any utterance made by my student in connection with their participation therein.
